with interest thereon from Date Received at the rate of 7 per cent. per annum, to be computed and paid Semi-annually by Retention

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as Lot No. 31 in Block "C" of the subdivision known as Augusta Court, as shown on a plat of record in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "F", page 124, and having according to said plat the following metes and bounds, to-wit: Beginning at an iron pin on the Northeastern side of Augusta Court joint corner of Lots Nos. 31 and 32, and running thence with the joint line of said lots N. 49-04 W. 180.4 feet to an iron pin; thence N. 55-30 E. 90 feet to an iron pin on a 20 ft. road; thence with said road S. 39-33 E. 175 feet to an iron pin at intersection of said Road and Augusta Court; thence with said Augusta Court S. 55-21 W. 60 feet to the point of beginning.
