at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said T.C. Gower, All that certain piece, parcel or lot of land

situate, lying and being in the City of Greenville on the East side of Cook St. and being more particularly described as follows: Commencing at a stake on the east side of Cook St. corner of lot conveyed by S.J. Easy to Cox; thence along line of cox lot N. 28-05 E. 75 feet to a stake; thence along rear line along property of Epps S. 2-0 E. 42 feet to an iron pin; thence along line of property to be deeded to William Earle S. 88-30 W. 75 feet to a stake on the East side of Cook Street; thence along the east side of Cook Street N. 2-0 W. 41 ft. to the point of beginning.

Also that other certain piece, parcel or lot of land situate in Ward One of the City of Greenville on the North side of Bond Street, or Extension of Frank Street, being lot No. 8 shown on plat of property of T.C.
