Dollars, to be paid as follows: \$252.94 six months after date, \$292.94 twelve months after date, \$252.94 Eighteen months after date, and \$252.93 twenty four months date.

with interest thereon from date at the rate of Seven per cent. per annum, to be computed and paid semi-annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Office for Greenville County in Plat Book F, at page 222, and having, according to said plat the following metes and bounds, to-wit:-

Beginning at an iron pin on the South side of Cauble Street joint corner of lots Nos. 6 & 7 and running thence with the joint line of said lots S. 20-25 W. 101.2 ft. to an iron pin; thence S. 70-30 E. 19 ft. to an iron pin in line of lot No. 8; thence with the line of that lot N. 20-25 E. 101.4 ft. to an iron pin on Cauble Street; thence with said Street N. 71-05 W. 19 ft. to the point of beginning.
