parcel of land situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as Lot No. 56 of the subdivision known as Augusta Circle as shown on a plat of record in the R.M.C. Office for Greenville County, South Carolina, in the Plat Book F., at page 23, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Augusta Drive and running thence with the joint line of lots 55 and 56, S. 21.35 W. 184.7 ft. to iron pin in line of lot 58; thence with line of lot 58, N. 71.35 W. 80 feet to iron pin in line of said lot; joint corner of lots 56 and 57; thence with the joint lines of lots 56 and 57, N. 21-35 E. 163.8 ft. to iron pin on Augusta Drive; thence with said Augusta Drive S. 86 E. 84 ft. to the point of beginning.
