I, W.A. Chandler, SEND GREETING:

WHEREAS, I, the said W.A. Chandler

in and by my certain promissory note in writing, of even date with these presents, on well and truly indebted to

Melville C. Westervelt, as Trustee

in the full and just sum of Eight hundred thirty-one and 25/100 (\$831.25)

Dollars, to be paid on or before one year after date

with interest thereon from this date at the rate of seven per cent. per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hand of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Melville C. Westervelt, as Trustee, All that certain lot or

parcel of land situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as Lot No. 98 of the subdivision known as Augusta Circle as shown on a plat of record in the R.M.C. Office for Greenville County in the Plat Book "F", page 23, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the Eastern side of Paris Road, the joint corner of lots Nos. 97 and 98, and running thence with the joint line of said lots S. 71-35 E. 165.1 feet to an iron pin, the joint corner of lots Nos. 85, 86, 97 and 98; thence with the joint line of lots Nos. 85 and 98, S. 21-35 W. 50 feet to an iron pin, the joint corner of lots Nos. 84, 85, 98 and 99; thence with the joint line of lots Nos. 98 and 99, N. 71-35 W. 160.7 feet to an iron pin on Paris Road; thence with the Eastern side of Paris Road N. 16-30 E. 49.96 feet to the point of beginning, being the same lot of land this day conveyed to me by Melville C. Westervelt, as Trustee.
