WHEREAS, *I, V. M. Manning*, the said *V. M. Manning* SEND GREETING:

in and by *my* certain *promissory* note..... in writing, of even date with these presents, *and* well and truly indebted to

in the full and just sum of *Six Hundred, Fifty-three and 34/100 (\$ 653.94)*

Dollars, to be paid *One-fourth in six months One-fourth in twelve months One-fourth in eighteen months, and One-fourth in twenty-four months*

with interest thereon from *date* at the rate of *Seven* per cent. per annum, to be computed and paid *semi-annually*

.....until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note.....to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note....., after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note..... or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10.....per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said *Melville C. Westerwelt, as Trustee*

all that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid near the City of Greenville, known and designated as Lot No. 20 in Block "C" of the subdivision known as Augusta Court as shown on a plat of record in the R. M. & Office for Greenville County in the Plat Book "F" page 124 and having according to said plat the following metes and bounds to wit:

Beginning at an iron pin on the East side of Augusta Court joint corner of lots Nos 19 and 20, and running thence with the joint-line of said lots S. 37-57 E. 194.6 feet to an iron pin, joint-corner of lots Nos. 20 and 1, thence with the joint-line of said lots N. 52-03 E. 70 feet to an iron pin, corner of lot No. 2, thence with the line common to Lots 2, 3 and 20. N. 37-57 W. 194.6 feet to an iron pin on the East side of Augusta Court, thence with said Augusta Court S. 52-03 W. 70 feet to the point of beginning.
