AND the said B. M. Wood agrees to insure the house and buildings on said lot in the sum of not less than Seven hundred and fifty Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said B. M. Wood and that in the event the mortgagor shall at any time fail to do so, then the said B. M. Wood may cause the same to be insured in his name, and reimburse him for the premium and expense of such insurance under this mortgage.
