And I do hereby bind my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Mary Black Hospital, their heirs and assigns, from and against me + my heirs, executors, administrators and assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

Campbell do and shall well and truly pay, or cause to be paid unto the said Mary Black Hospital the said debt or sum of money aforesaid, with interest thereon, if any shall be due, according to the true intent and meaning of the said Note then this deed of bargain and sale shall cease, determine and be utterly null and void; otherwise to remain in full force and virtue.
