Rollins agree to insure the house and buildings on said lot in the sum of not less than Dollars, and keep the same insured from loss or damage by fire and assign the policy of insurance to the said James L. Rollins and that in the event the mortgagor shall at any time fail to do so, then the said James L. Rollins may cause the same to be insured in James L. Rollins name, and reimburse James L. Rollins for the premium and expense of such insurance under this mortgage.

Rollins the said debt or sum of money aforesaid, with interest thereon, if any shall be due, according to the true intent and meaning of the said promissory note then this deed of bargain and sale shall cease, determine and be utterly null and void; otherwise to remain in full force and virtue.

AND IT IS AGREED, by and between the said parties, that James L. Rollins to hold and enjoy the said premises until default of payment shall be made.
