assigns, the following tract of land: "All that parcel of land lying and situate in
 Greenville County, State aforesaid, known as Lot No. 5 of plat made by J. H. Atkins,
 Surveyor, November 3, 1918, and sold at auction in 1918; Beginning at a stone on road at
 crossing of Belue's Mill Creek, and running thence with road to stone; thence N. 56 E.
 6.95 to a pin; thence S. 82 1/2 W. 1.98 to stone S. O. gone; thence S. 63 1/2 W. 4.20 to stone, Maple
 Gone; thence with creek to the Beginning corner, containing 65.68 acres, 27 acres of
 which is the same lands conveyed to M. A. Belue by Mitchell Thomas, by deed dated
 October 10th, 1889, recorded in Volume "UU", at page 645, the other 38.68 acres being a
 part of the tract conveyed to Elvira Belue by L. H. Hill, Master, by deed dated 1895,
 and recorded in Vol. "AAA", at page 824.
