and just sum of Ten Thousand + 20/100 Dollars,

to be paid on or before the date when the 3rd Series of the Association

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

All that certain lot or parcel of land situate, lying and being in a subdivision of the City of Greenville, known as Cagle Park, said lot being known and designated as lot 15, Block B., on the plat of said property, and having the following metes and bounds, to-wit: Beginning at an iron pin on Mills Avenue, corner of lots 14 and 15, B. thence with Mills Avenue S. 72-10 E. 67 feet to an iron pin on joint corner of lots 15 and 16, Block B; thence N. 0-54 W. 196.8 feet to an iron pin; thence N. 77.44 W. 63.6 feet to an iron pin; thence S. 0-23 E. 190.2 feet to an iron pin at beginning corner.
