in and by my certain promissory note in writing, of even date with these presents, well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full

and just sum of Eight Hundred Dollars,

to be paid on or before the date when the 3rd Series of the Installment

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All that piece, parcel or lot of land in Greenville Township Greenville County state of South Carolina about two miles of Greenville Court House and being a portion of a subdivision known as City View, Beginning at a stake on the north east corner of O'Neil Street and M^cD. Avenue and running thence N. 1/2 E. 150 feet to a stake on M^cD. Avenue same being joint corners of lots no. 103 and 104 and running thence with joint lines of said lots S. 89 1/2 E. 150 feet to a stake on a ten foot alley; thence S. 1/2 W. with line of said alley 150 feet to a stake on O'Neil Street; thence N. 89 1/2 W. with line of said street 150 feet to a stake at the beginning corner and being designated as lots nos. 101, 102 and 103 according to plat made by W.
