I, J.C. Martin, of Greenville County, State of South Carolina SEND GREETING:

WHEREAS, I, the said J.C. Martin

and just sum of Seven hundred (\$700.00) Dollars,

to be paid on or before the date when the 2nd, Series of the Installment

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION All that certain piece, parcel and lot of land situate,

lying and being in the County and State aforesaid just outside the corporate limits of the City of Greenville, on the corner of Anderson Road and a 33 foot road running from Anderson Road toward Judson Mills and known as George's Road, facting 80 feet on Anderson Road and facing a distance of 125 feet on George's Road, being a parallelogram and being a portion of the lot conveyed to me by George B. Thruston, by deed bearing date May 19, 1906 and recorded in C. Office Greenville County in Volume 388, page 360.
