WHEREAS, I, the said Lucile S. Boyd

in and by my certain promissory note in writing, of even date with these presents, well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full

and just sum of Fifteen hundred and no/100 Dollars,

to be paid on or before the date when the 5th, Series of the Installment

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

I fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Lucile S. Boyd

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me the said Lucile S. Boyd

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All my undivided interest in that certain piece, parcel or lot of land situate and being in County and State aforesaid, in Paris Mountain Township, on Lake Circle Road, beginning at a stake on the west side of Lake Circle Road, corner of lot #38, along line of lot #38, S. 85-30 W. 450 feet to a stake on the Altamont Road; thence with said Altamont Road 275 feet to a stake corner of lot #40; thence along line of lot #40, N. 86-0 E. 233 feet to a stake on the west side of Lake Circle Road; thence with Lake Circle Road 200 feet to the beginning, corner, containing 1.56 acres, more or less. Being the same lot of land deeded to me and Hattie S. Moran by Paris Mountain Company by deed dated August 8th, 1921, recorded in R.M.C. Office for Greenville County in Vol. 53, page 459.
