I, *H. W. Hudson* of the State and County aforesaid

SEND GREETING:

WHEREAS, *I*, the said *H. W. Hudson*

in and by *my* certain promissory note in writing, of even date with these presents, *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Twenty five Dollars* Dollars, to be paid on or before the date when the *5th* Series of the *Installment*
