I, Wm. H. Hanckel, of Greenville, S. C.

SEND GREETING:

WHEREAS, I, the said Wm. H. Hanckel

in and by my certain promissory note in writing, of even date with these presents and well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Twenty five hundred Dollars, to be paid on or before the date when the 6th Series of the installment

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

I fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I the said Wm. H. Hanckel

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me the said Wm. H. Hanckel

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the Subdivision known as "Kanatenah", and situated on the north side of Oregon Street, and known as Lot #5 of Block C., on plat of the said property recorded in R.M.C. Office for said County in Plat Book F, at pp. 66 - 67. The said lot has the following metes and bounds: beginning at a stake on north side of said Street, at corner of lot #4 of said Block, and running along said Street N. 63-30 E. sixty feet to stake at corner of lot #6; thence along said lot N. 26-30 W. one hundred and sixty-five feet to stake at corner of lot #14; thence along said lot S. 63-30 W. sixty feet to stake at corner of lot #4; thence along said lot S. 26-30 E. one hundred and sixty-five feet to the beginning point on said Street. This is the same lot conveyed to me, the said Wm. H. Hanckel by F.A. Lawton, a deed dated July 25th, 1922, and recorded in said R.M.C. Office in Vol. #89 at page 99.
