All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, near the corporate limits of the City of Greenville in section known as Cherokee Park, and being known and designated as Lot #2 on plat of E.N. Green property recorded in the R.M.C. Office for Greenville County in Plat Book E., at page 287, and being also known as a part of lots 11 & 12 of the South Cherokee Park Lands as shown on plat of said land recorded in the R.M.C. Office for Greenville County in Plat Book A., at page 130, having the following metes and bounds, to-wit:

Beginning at an iron pipe on Saluda Ave., 72 feet from the intersection Saluda Ave. and Keowee Ave., and running with Saluda Ave., N. 62-50 W. 50 feet to an iron pipe, corner lot #1; thence with line of lot #1 S. 26-50 W. 100 feet to iron pipe in line of lot #3; thence with line of Lot #3, S. 62-50 E. 50 feet to an iron pipe at corner of lot #4; thence with line of lot #4, N. 26-50 E. 100 feet to the beginning corner, and being one of the lots conveyed to me by E.N. Green by deed dated Aug. 23rd, 1920, which deed is recorded in the R.M.C. Office for Greenville County in Book Vol. 62, at page 223.
