And the said mortgagor agree to insure the house and buildings on said lot in a sum not less than Nine Hundred and  
fifty Dollars (in a company or companies satisfactory to the mortgagee...), and keep the same insured from loss or damage

the rents and profits actually collected.

PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if I, the  
said mortgagor..., do and shall well and truly pay or cause to be paid, unto the said mortgagee..., the said debt or sum of money aforesaid, with interest there-  
on, if any be due, according to the true intent and meaning of the said note, then this deed of bargain and sale shall cease, determine, and be utterly null and void;
