and assigns forever All that certain piece parcel or lot of land
situate lying and being in the County of Greenville, and
State of South Carolina about three miles from the Greenville
County Court House, on an un-named street and described
as follows, to-wit:

Beginning at a pin on the East side of said un-named
street one hundred twenty-five feet from the northeast corner
of the National Highway and said un-named sixty foot street
and running thence North 80 degrees 35 min. East one hundred
ninety-five feet more or less to a pin; thence North 5 degrees
15 min. West one hundred twenty five feet to a pin; thence
South 80 degrees 35 min. West one hundred ninety-eight
feet to a pin; thence with said un-named sixty foot street
South 7 degrees 30 min. East one hundred twenty-five feet to
the beginning corner, being the northern portion of Lot Number
Seven of a plat of "Crompt Stone Acres" said plat being recorded
in Plat Book "E" at page 35-36 in the office of the R. M. C.
for Greenville County, this being the same lot of land
