Beginning at a point on Walnut Street, joint corner of lots Nos. 10 and 9, and running
thence along Walnut Street N. 30-40 W. 50 feet to a point, joint corner of lots Nos. 10
and 11; thence along line of Lots Nos. 10 and 11, S. 59-20 W. 145.6 feet to a point, joint
corner of lots Nos. 10 and 11; thence S. 28-05 E. 50.02 feet to a point, joint corner of
Lots Nos. 9 and 10; thence along line of lots Nos. 9 and 10, N. 59-20 E. 148.9 feet to
