grant, bargain, sell and release unto the said Susan C. Gallivan

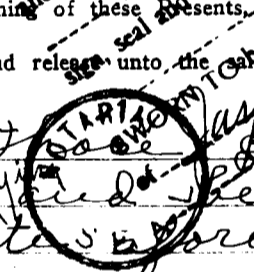
