grant, bargain, sell and release unto the said Mrs. J.M. Lemort, that piece or parcel of land in the State

of South Carolina known and described as follows: Beginning at a stake on the east side of
Greenville-Hendersonville Highway, which stake is on the northwest corner of the
Trammell tract and running thence with the Greenville-Hendersonville Highway N. 8 degrees
West 200 feet to a stake; thence South 41 degrees East 1942 feet to a stake in Trammells
line; thence with Trammells line North 16 degrees West 908 feet to a stake; thence with
Trammells line South 87 degrees West 1900 feet to the beginning, containing Thirty-one
(31) acres, more or less, and being a part of tract of one hundred and twenty-eight acres
(128) which was deeded by A. Justis to P.L. Wright.
