interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for attorney's fee of ten dollars, to be added to

grant, bargain, sell and release unto the said J.J. Wood.

All that certain piece, parcel or lot of land situate, lying and being in the State and
County aforesaid in Chick Springs Township near the Town of Greer on the North side of the
National Highway and having the following metes and bounds, to-wit:-
Beginning at a stake on the said National Highway, Haynes corner and runs thence with her
line North 190 feet to a stake; thence S. 87.15 W. 70 feet to a stake in field; thence
South 190 feet to said National Highway; thence N. 87.25 E. 70 feet to the beginning corner,
and being the same land conveyed to me this date by J.J. Wood.
Also all that other piece, parcel or lot of land situate, lying and being in the State and
County aforesaid in Chick Springs Township, on the North side of the National Highway and
having the following metes and bounds to-wit:
