I, Carrie Belle Gilbreath of Greenville County in the state of South Carolina. SEND GREETING:

WHEREAS, I, the said Carrie Belle Gilbreath of the said state and county
in and by my certain promissory note in writing, of
even date with these presents, am well and truly indebted to

Alice C. Hicks of Greenville county in the said state
in the full and just sum of One thousand and no/100 &
Dollars, to be paid one year from date

with interest thereon from date at the rate of 8 per cent. per annum to be
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent on amount due besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference
being thereunto had, as will more fully appear.

grant, bargain, sell and release unto the said Alice C. Hicks and her Assigns:

All that lot or parcel of land situate, lying and being in ward #1, in the city of Greenville S.C. on Townes St, fronting on the said Townes St. 50.8 feet and running back 171.7 feet on the lower line, and 179 feet on the upper line being 89.7 feet wide on the back line, and being a part of the lot of land conveyed to Alice C. Hicks by R. C. McLees and being the same lot conveyed to me by Alice C. Hicks by deed dated April 23rd, 1921 and recorded in P.M.C. office for Greenville County in vol. 71 at page 464. It is hereby agreed and understood that this mortgage is second to mortgage given by me to The Equitable Life Assurance Society of the United States on July 6th 1921 for \$3750.00 to be paid in 120 equal monthly installments of \$51.75 each and covering the above described lot of land, said mortgage being of record in the office of the P.M.C. for Greenville County in vol. 117 at page 34.
