All that certain lot or parcel of land situate, lying and being in the county and state aforesaid on the north side of Arlington Avenue in the city of Greenville, and having the following meters and bounds, to-wit:  
Beginning at an iron pin on the north side of Arlington Avenue the southeast corner of Mc Gee lot, and running thence with line of Mc Gee lot N. 28 E. 94 feet to an iron pin in line of Mc Gee lot and lot now or formerly owned by C. O. Allen; thence with line of lot now or formerly owned by C. O. Allen S. 64 1/2 E. 50 feet to an iron pin; thence approximately S. 28 W. 90 feet more or less, to an iron pin abv Arlington Avenue, which pin is 50 feet eastward from the point of beginning; thence along the northern side of Arlington Avenue N. 41 W. 50 feet to the point of beginning.
