WHEREAS, I, the said Mrs. Bertie E. Burns

in and by BY certain promissory note in writing, of even date with these presents BY well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full

and just sum of Twelve hundred no/100 Dollars,

to be paid on or before the date when the 3th, Series of the Instalment

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

I fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION All that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, known as Lot No. 3 of subdivision of property of Mrs. Bertie E. Burns as shown on plat of said property made by C.M. Furman, Jr. Engineer, February 12, 1923, said lot having a frontage of 60 feet on Old Harris Road, with a depth on one side of 144 feet and on the other of 136 feet, rear line 55 feet.

Being a portion of the same conveyed to Mrs. Bertie E. Burns by J.R. Yown and W.T.-Leeper by deed dated January 6, 1920, and recorded in Vol. 69, page 10.
