Greenville County, State of South Carolina, near Monaghan Mills, about three-quarters of a mile beyond the corporate limits of the City of Greenville, being known and designated as lot No. 93 of Morgan Hill Addition, according to plat thereof recorded in office of R.M.C. for said State and County on June 21st, 1902, in Plat Book A, page 70, said lot having the following metes and bounds:

Beginning at a stake on the east side of Parker Avenue, at corner of lot No. 22 and running thence Eastwardly 199 feet along line of said lot No. 92 to a stake; thence Northwardly 54 feet along line of lot No. 88 to a stake on line of Monaghan Mills land; thence N. 83-1/2 W. along line of said Monaghan Mills 200 feet to a stake on the east side of said Parker Avenue; thence Southwardly along said Parker Avenue 58 feet to the beginning corner. The above described lot was conveyed to me by Mrs. Mattie Orr by deed dated February 28, 1921, recorded in Book 70, page 458, and by deed dated April 2, 1923.
