South Carolina, in the subdivision known as Riverside, being known and designated as Lot No. 3 in Block DD on plat of said subdivision recorded in Office of R.M.C. for said County in Plat Book A, page - having a frontage of fifty feet on Colonial Avenue, with a depth of 125 feet to an alley, and being the same conveyed to me by J.J. Odam by his deed dated March 13th, 1923, this day recorded.
