SEND GREETING:

WHEREAS, *I*, the said *Mrs Bertie E. Burns*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *Twelve hundred (\$1200.00) and ²⁰/₁₀₀* Dollars, to be paid on or before the date when the *9th* Series of the *Instalment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

I fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear

NOW, KNOW ALL MEN, That *I* the said

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me* the said *Mrs Bertie E. Burns*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION *its successors and assigns forever: All that piece, parcel or lot*

of land being in Greenville Township, Greenville County, State of South Carolina, known as Lot No. 6 of subdivision of property of Mrs. Bertie E. Burns, as shown on plat of the said property made by C.M. Furman, Jr., Engineer, February 12, 1923, and having the following metes and bounds, to-wit:

Beginning at joint corner of Lot No. 5 on the Old Harris road and running S. 74 W. 60 feet with said road; thence N. 16-30 W. 120 feet; thence N. 78-30 E. 55 feet; thence S. 18 E. 115 feet to the beginning corner.

This being a portion of the land conveyed to the said Mrs. Bertie E. Burns by J.R. Yown and W.T. Loper by deed dated the Sixth day of January 1920, and recorded in the R.M.C. Office for Greenville County in Vol. 69 at page 10.

This also being one of the lots released from the mortgage covering the land referred to in the preceding paragraph; said release being of record in the R.M.C. Office for Greenville County of Deeds, Vol. 85, page 276.
