Morgan's corner, and running thence with her line N. 67-2 W. 280 feet to a stake on Douthit Alley; thence with said Alley N. 18-2 E. 54 feet to a stake; thence S. 67-20 E. 280 feet to a stake on Westfield Street and thence with said Street S. 18-20 W. 54 feet to the beginning corner, adjoining lots of W.B.
