Greenville County, South Carolina, near the City of Greenville, being a portion of lots 22 and 23 in a subdivision known as Eastover, plat of which is recorded in R.M.C. Office for Greenville County in Plat Book F., page 42, and having the following metes and bounds: Beginning at a stake on the north side of Beechwood Avenue, 175.5 feet east from corner of lot No. 21, at corner of lot sold by me to Mattie E.
