AND LOAN ASSOCIATION All that lot of land situate in the City of Greenville, State and County aforesaid, and described as follows: Beginning on the south side of Elkins Street, at corner Whitmire's lot; thence with Elkins Street N. 80.45 W. 50 feet to corner O.M.-Howard's lot; thence with the line of Howard's lot S. 0.30 E. 192 feet to corner on Harris line; thence with Harris line N. 67 E. 53-1/2 feet to Whitmire's corner; thence with Whitmire's line N. 0.30 W. 67 feet to the beginning corner on Elkins Street, and being the same land conveyed to me by W.D.
