SEND GREETING:

WHEREAS, the said James Finley and Sarah Finley

in and by our share of it certain promissory note in writing, of even date with these presents, are well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of Three thousand one hundred five + 20/100 Dollars, to be paid on or before the date when the 11th Series of the Instalment

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

and County aforesaid, on the northern side of Lafayette Street just outside the City of Greenville, being Lot No. 26 of "Washington Heights" subdivision according to a plat made by C.M. Furman, Jr., February 3, 1922, and recorded in the R.M.C. Office for Greenville County in Plat Book F, at page 54; said lot fronting 35 feet on Lafayette Street and having a depth of 100 feet.
