to be paid on or before the date when the - Series of the Instalment

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION All that certain land situate in Greenville Township, State and

County aforesaid, on the eastern side of Burnett Avenue, in the City of Greenville, being Lot No. 65 of Washington Heights subdivision according to a plat made by C.M. Furman, Jr., February 3, 1922 and recorded in the R.M.C. Office for Greenville County in Plat Book "F" at page 54; said lot fronting 35 feet on Burnett Avenue and having a depth of 87.5 feet. Being the same lot of land conveyed to us by the Norwood National Bank as Trustee by deed dated March 3, 1924, not yet recorded.
