All that certain lot of land in Greenville Township, Greenville County, South Carolina, near the City of Greenville, known and designated as a portion of lots Nos. 34 and 35 of Morgan Hill Addition, plat of which subdivision is recorded in R.M.C. Office for Greenville County in Plat Book A, page 69, and having the following metes and bounds:

Beginning at a point on the east side of Brandon Road (which point is 49.85 feet N. 13-3/4 E. from the intersection of Brandon Road and Morgan Street) and running thence N. 82-3/4 E. 100 feet to a stake; thence S. 7-1/4 E. 43.3 feet to a stake; thence S. 82-3/4 W. 118.3 feet, more or less, to a stake on Brandon Road; thence with Brandon Road S. 13-3/4 W. 50 feet to the beginning corner, being a portion of the same conveyed to me by John T.
