WHEREAS, *I*, the said *G. B. Lee*

in and by *myself* certain promissory note in writing, of even date with these presents *and* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *Twenty-five Hundred & no/100* Dollars, to be paid on or before the date when the *15th* Series of the *Installments* Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

AND LOAN ASSOCIATION *All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, designated as Lot No. 11, in the subdivision of Eastover as shown by plat recorded in Plat Book F, page 42, R.M.C. records for Greenville County, said lot having a frontage of 65 feet on Beechwood Avenue, a depth of 136.4 feet along line of Lot No. 10, a depth of 241.4 feet along line of Lot No. 12, and a width of 72 feet in the rear.
