in and by *my* certain promissory note in writing, of even date with these presents, *and* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full

and just sum of *Five Hundred & no/100* Dollars,

to be paid on or before the date when the *14th* Series of the *Instalment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I*

AND LOAN ASSOCIATION All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville in Subdivision known as "Kanatenah", and known as Lot #7, in Block A., in plat of the said property, recorded in R.M.C. The said lot has the following metes and bounds: Beginning at a stake on the South side of Oregon Street, corner of lot #6 in said Block, and running thence along Oregon Street, N. 63-30 E. 60 feet to stake at corner of lot #8; thence along said lot S. 26-30 E. 165 feet to stake; thence S. 63-30 W. 60 feet to stake; corner of lot #6; thence along said lot N. 26-30 W. 165 feet to the beginning point on Oregon Street.
