WHEREAS, *I*, the said *l. E. Proffitt*

in and by *my* certain promissory note in writing, of even date with these presents, *and* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *One Thousand ^{no}/₁₀₀* Dollars, to be paid on or before the date when the *16th* Series of the *Instalment*
