Greenville County, State of South Carolina, known and designated as Lot No. Two in Block A, of Subdivision of land known as Sunny Slope lying about two miles west of the City of Greenville, said lot fronting on Fortner Street, having a frontage of fifty feet on said Street and having a depth of One hundred and fifty feet, between parallel lines; same being according to plat of said subdivision made by R.
