Greenville County, State of South Carolina, about 2 1/4 miles northwest from Greenville Courthouse, in the section known as Sans Souci and being on Davis Street, and known as Lot No. 28 on a plat recorded in Plat Book Co page 158, and having the following metes and bounds: Beginning at an iron pin on the west side of Davis Street, corner of lot No. 27 and running thence N. 74-26 W. 175 feet to a pin; thence S. 17-45 W. 65 feet to a pin; thence S. 74-26 E. 175 feet to a pin on Davis Street; thence with said Davis Street N. 17-45 E. 65 feet to the beginning corner.
