Greenville County, South Carolina, near Judson Mills, known as Lot No. 12 on plat of property of W.H. McGaha, recorded in office of R.M.C. for said County in Plat Book F., Page 33, and having the following courses and distances according to said plat: Beginning at an iron pin northwest corner of Honour and Cobb Streets and running thence with Honour Street N. 56 W. 134.3 feet to pin, corner of lot No. 1; thence with line of lots Nos. 1 and 2, N. 51-20 E. 69.1 feet to iron pin, corner of lot No. 11; thence with line of said lot S. 51-30 W. 128.9 feet to iron pin on Cobb Street; thence with said Street S. 48-30 W. 57.8 feet to the beginning.
