AND LOAN ASSOCIATION that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being a part of the subdivision known as McCullough Heights and Lot No. 4, as per plat of said subdivision made by R.W. Office for said County and State, plat Book E, page 95, reference to which is hereby craved, being the same lot of land conveyed to me by Joseph A. McCullough by deed dated Aug. 4th, 1922, recorded in Book H, of Deeds, page 390.
