to be paid on or before the date when the 7th Series of the Instalment

AND LOAN ASSOCIATION All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, State and County aforesaid, being a portion of Lot No. of Block A, as shown by a plat recorded in R.M.C. Office for Greenville County in Plat Book A, pages 122 and 123, and having the following

metes and bounds, to-wit: Beginning at an iron pin on the West side of Sumner Street one hundred and fifty (150) feet North of corner of Annington Avenue and Sumner Street; thence with line of Sumner Street N. 17 E. fifty-one (51) feet, more or less, to an iron pin corner of lot owned by T.A. Baugh; thence N. 72-85 W. seventy-five (75) feet to an iron pin in line of Lot No. 4; thence with line of Lot No. 4, S. 17 W. fifty-one (51) feet to an iron pin; thence S. 72-85 E. 75 feet to the beginning corner, and being the same lot of land conveyed to me by Kate M.
