to be paid on or before the date when the *7th* Series of the *installment*

All that certain piece, parcel or lot of land situate lying and being in the state of South Carolina, County and Township of Greenville on Pendleton Road in West Greenville and being known as lot No. 1 of the Brandon Amey and having the following metes and bounds, to wit: Beginning at a stake on Pendleton Road, joint corner of lot No. 2 and running thence with the new road (recently made) in a northeasterly direction 75.4 feet to a stake corner of street, adjoining "Downwood"; thence with said street 93 feet to a stake, joint corner of lot No. 13; thence S. 51 E. 4.4 feet to a stake; thence S. 23-30 E. 130 feet to the beginning corner and being the same lot deeded me by J.
