WHEREAS, I, the said D. W. Bryant

in and by my certain promissory note in writing, of even date with these presents, due well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of Fifteen Hundred - no/100 Dollars,

to be paid on or before the date when the 5th Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION All that piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, South Carolina, near Monaghan Mills, and known and designated as lot No. 20 on the plat of Riverside, which plat is recorded in Plat Book A., page 323, in Block U. on said plat. Said lot being at the corner of Highlawn Avenue and Green Street, having a frontage of 50 feet on Highland Avenue and running back in parallel lines of 125 feet to an alley, one of the lines being along Green Street. Being a portion of the same conveyed to me by A.E. Stroud by deed dated July 31, 1920, recorded in Book 73, page 2.
