AND LOAN ASSOCIATION All that certain lot or parcel of land situate, lying and being in the

City of Greenville, County and State aforesaid, on the north side of Means Street, and having the following metes and bounds, to-wit:  
Beginning at an iron pin on Means Street approximately 100 feet eastward from the northeast corner of Means and St. John Streets, and running thence with Means Street approximately 100 feet to an iron pin; thence in a northwesterly direction approximately 150 feet to an iron pin in line of lot now or formerly owned by H.
