interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent (10%)* besides all costs and expenses of collection, to be added to

thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference

described as follows: Beginning at a stake in the center
of the Greenville Asheville highway at the point where
said Highway crosses the Johnson line and running thence
with the Johnson line South 39 degrees West 965 feet more
or less to a Chestnut tree in the Ward line; thence with
the Ward line North 73 degrees East 924 feet to a stake
in the center of the present Greenville Asheville highway
thence with the said highway at a northwesterly direction
about 650 feet to the beginning containing seven acres
more or less and whether more or less same is not
to affect the considerations of this deed.*
