Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim, the same, or any part thereof.

And the said mortgagor agree to insure the house and buildings on said lot in a sum not less than Seventeen Hundred
Dollars (in a company or companies satisfactory to the mortgagee), and keep the same insured from loss or damage
