All that certain piece, parcel or lot of land, situate, lying
and being in the State and County aforesaid, in Greenville
County, on the north side of Broad Road just outside
the corporate limits of Greenville, S.C. and being known
and designated as a part of Lot #14 in Block 22, of
O.P. Miller property as shown on a plat of record in Plat
Book 6, page 179, and described as follows, to wit;

Begins at a iron pipe on the north side of Broad
Road, which pipe is 281 feet from the northwest corner
of Broad and Augusta Roads, and is the front corner
of Lots #13 and 14 thence with the front line of said lots, 71
48-22 N 147' feet to a stake, thence in a southwesterly direction
as a straight line 58' more or less to a stake on
12 foot private driveway which stake is 125 feet from the
northern side of Broad Road, thence along the eastern side
