WHEREAS, I, the said Amanda Turner  
in and by my certain promissory note in writing, of

in the full and just sum of One hundred and fifty (\$150.00)  
Dollars, to be paid on or before ten (10) years after date hereof

with interest thereon from this date at the rate of six per cent. per annum to be  
computed and paid annually  
until paid in full, all interest not paid when due to bear interest at the same rate as principal. and if any portion of principal or  
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

fifty dollars besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference  
being thereunto had, as will more fully appear.

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said Mary T. Smith, and her heirs and assigns. All that certain piece,

parcel or lot of land with the improvements thereon, situate, lying and being in the State of  
South Carolina, and County and City of Greenville, in the Fifth Ward of said City, on Rhett  
Street and having the following metes and bounds, to-wit:

Beginning at a pin on the north side of Rhett Street, corner of L.P. Hawkins lot, and running  
thence with Hawkins' line N. 18-40 W. 114 feet to a stake in Hawkins' line; thence S. 71-20  
W. 64 feet to a stake on Pack's line; thence S. 18-40 E. 114 feet to a stake on North side  
of Rhett Street; thence with line of said Street N. 71-20 E. 64 feet to the beginning corner,  
and containing 7296 ft. more or less.
